The construction of Kunming Rail Transit Line 4 is a northwest-southeast auxiliary line connecting the main city and Chenggong, linking the National Hi-tech Industrial Development Zone in the northwest of the main city, central district of the main city and the National Economic and Technological Development Zone in the southeast of the main city and extending to Chenggong New City in the south. The Line is in a total length of 43.49km with 29 stations. The total construction period is not exceeding five years, which is scheduled to be commenced in 2016 and completed in 2020.
